This summer, I had the privilege of being seconded to the Toronto International Film Festival ("TIFF") for the last four weeks of my summer at Fasken. TIFF is an amazing not-for-profit organization that not only runs one of the world's most renowned and publically attended film festivals, but that also contributes greatly to the creative arts and film community in Canada through their year-round charitable efforts.

#### Julie He - OSC

I had the great opportunity to be seconded to the Enforcement Branch of the Ontario Securities Commission ("OSC"). As an independent Crown corporation, the OSC administers and enforces compliance of the *Securities Act* (Ontario). The Enforcement Branch is specifically tasked to investigate, exam and litigate misconduct and prosecute wrongdoers. With a strong interest in the capital market, particularly the intersection of securities law and fintech, I am grateful to be a part of the OSC where regulatory discussions take place concerning emerging issues such as cryptocurrency.

I was able to deepen my learning of the securities law itself through conducting case law research, drafting memos and summaries. I was fortunate to participate in all the public hearings during my time at the OSC, as well as to observe a compelled examination and a settlement discussion. On top of the interesting work, I have enjoyed connecting with staff members in other branches and gained a better understanding of how OSC safeguards investors through its rule-making and enforcement powers.

#### Summer Ibrahim - Mount Sinai

This summer, I had the unique experience of working with Sinai Health. Despite having had little familiarity with health law, I was quickly immersed in the complex and intriguing questions that hospitals have to find solutions to on a daily basis.

North America's leading hospitals, Sinai included, are constantly innovating and developing technologies that advance patient care. I helped the legal team by researching privacy and related issues impacting health technology – a topic that I found fascinating. I also drafted agreements between Sinai Health, scientists, and

medical experts. Drafting such novel partnership agreements often raised intriguing questions relating to intellectual property law requirements.

Sinai Health's commercial services further extend to some of the hospital's shops. This provided me with the unique opportunity to research contest law requirements for a coffee shop located in the hospital. My time at Sinai Health canvassed varying areas of the law – touching subjects from legal research, corporate-commercial services, intellectual property, competition law, and various other subjects.

I gained greatly from working with Ross DeBoni, Melanie De Wit, and Paula Kocsis. The entire team at Sinai Health was supportive and receptive to my work. I would like to thank everyone I worked with. ### **Timothy Law - Pro Bono Ontario**

During the course of my summer with Fasken, I had the pleasure of spending four weeks working with Pro Bono Ontario's Law Help Centre. The Law Help Centre is a service dedicated to providing individuals who cannot afford legal representation with assistance in navigating the complex legal system in the Superior Court of Justice and Small Claims Court.

Over the course of my secondment, I gained valuable experience interviewing clients to understand their specific legal concerns, briefing lawyers on client cases, shadowing lawyers in client meetings, and assisting clients in drafting their legal documents. Being exposed to a diverse number of peculiar legal issues, PBO provided an amazing opportunity to become familiar with civil procedure in a highly practical and engaging manner. As I was able to further discuss client issues and present my own opinions to different lawyers and PBO staff, I was able to also greatly develop my legal acumen and gain an understanding of how to practically engage with client needs and expectations.

Furthermore, this experience also illustrated the difficulty many individuals face in using the Court system. Seeing such challenges provided me with a greater appreciation for both the benefits and flaws of Ontario's Court system, and how legal professionals should take on an additional responsibility to assist such individuals in promoting access to justice.

Consequently, for any student interested into litigation or wishing to gain a practical understanding of the courts and civil procedure, I would highly (if not strongly) recommend a secondment with PBO. The knowledge and skills I have learned at PBO will certainly be beneficial as I move back to the firm for articling and beyond.

### Yvonne Mazurak - OSC

My secondment to the Ontario Securities Commission ("OSC") was one of the highlights of my summer at Fasken. The OSC is a Crown corporation that regulates Ontario's capital markets, by developing rules that govern the securities industry and monitoring firms and individuals for compliance with Ontario securities law.

I was placed in the Enforcement Branch, where I worked alongside the team that investigates allegations of misconduct and initiates enforcement proceedings. I had the opportunity to be involved in a number of files at various stages of litigation, by researching novel legal issues and attending hearings and examinations. In only four weeks, I learned a great deal and gained an immense appreciation for the role of securities regulators.

I would strongly recommend a secondment with the OSC. #### Rebecca Rossi - Ontario Labour Relations Board

During my summer term at Fasken, one of the highlights was the opportunity to be seconded at the Ontario Labour Relations Board (the "Board"). The Board is an independent adjudicative agency of the Ontario Ministry of Labour, mandated to mediate and adjudicate a variety of employment and labour relations-related matters. Due to my interest in labour and employment law, my time at the Board was an eye-opening experience which exposed me to "insider knowledge" of the Board and of the various legal matters which fall under its jurisdiction.

From day one at the Board, I felt like I was a part of the team and was quickly introduced to the world of labour and employment adjudication. I was often personally invited by the Vice-Chairs of the Board to attend their hearings so that I may observe and learn from them. Over the course of my four weeks, I had the pleasure of observing applications concerning unfair labour practices, certification applications, reviews of employment standards decisions, appeals of health and safety inspector decisions and construction grievances. I was also fortunate to observe a judicial review of a Board decision at the Divisional Court concerning whether an employer's work fell under federal or provincial jurisdiction.

When I was not observing hearings, the Vice-Chairs of the Board often sought my assistance in performing legal research. As well, on several occasions, I was asked to review draft decisions of the Vice-Chairs and to provide my feedback. These tasks enabled me to become involved in the adjudicative process and served as invaluable learning experiences.

I would like to personally thank my supervisor, Aaron Hart, as well as everyone else at the Board, for going above and beyond to make my secondment experience both interesting and enjoyable. I would also like to thank Eowynne Noble and the entire Professional Development Team at Fasken for facilitating this learning opportunity.

### **Heather Whiteside - SickKids**

My work with the legal services team at SickKids was engaging and diverse. I have a keen interest in health law and this secondment was the perfect opportunity to explore this area of law in a different context.

I worked primarily with the General Counsel at SickKids, Chris Viney, who made every effort to ensure that I was doing work that I found interesting and worthwhile. I benefited from the fact that the legal services team is involved in a wide variety of projects; the substantive areas of law that I looked at varied significantly from day to day. I wrote research memos on issues relating to the hospital's pension plan, the use of leftover biological material, and the legal risks and benefits of virtual care. I was tasked with ensuring that corporate records were organized and compliant with governing legislation, and was also involved in conversations on the impact of changes to Ontario's *Construction Act*. I appreciated this diversity of work.

This secondment was a useful introduction to the particular dynamics of in-house legal work. I learned how the priorities and constraints of an in-house legal team differ from those of a law firm. The legal services department at SickKids has a deep understanding of the hospital's goals and functions, allowing counsel to effectively support and advise on anything and everything happening in the hospital. This requires a significant amount of collaboration with other stakeholders, which I observed while participating in working group meetings on a

construction project. It was interesting to see the role that legal counsel played in multi-faceted discussions involving members of the finance and building operations teams.

My experience at SickKids has given me a new perspective on health law and in-house legal work that will serve me well as my career progresses as Fasken.

### **Krysten Zator - UHN**

During my summer at Fasken, I had the wonderful opportunity of working with the legal department team at the University Health Network (UHN) under Marc Toppings, Vice President and Chief Legal Officer. Through this experience, I gained enormous exposure to the legal aspects of running a large hospital and research centre, as well as the experience of in-house counsel.

At UHN, I had the opportunity to assist with a number of research and contract drafting tasks related to clinical research, privacy, property law, legislation, and unique projects the hospital was involved in. In addition to this work, I was fortunate to observe a day-long trial and several phone conversations, where I witnessed how a contract is negotiated, and observed how a lawyer assesses and conveys legal advice in response to a multifaceted and nuanced health law issue with no clear legal answer. All of these experiences helped refine my ability to spot legal issues more practically, and think about their resolution in creative and realistic ways.

To highlight one particular experience, I was fortunate to be brought onto a very unique project the hospital was engaging in, and participate from the initial research stage to the completed first draft of the agreement, which was prepared for negotiation. For this project, I was first asked to research relevant legal issues, then observe a phone call where the agreement for this project was discussed and legal issues were addressed. Based on this information, I created the first draft of a comprehensive agreement where I was fortunate to be mentored by Marc and Sandeep Deol, Legal Counsel, in contract drafting and legal strategy.

I want to thank Marc for providing this opportunity to second to UHN and ensuring that I received exposure to a variety of challenging work, especially in areas and tasks I expressed interest in. I want to further thank the rest of the excellent legal team at UHN who I had the privilege of working with including Sandeep, who I specifically thank for her thoughtful mentorship, Carole Garmaise, Frank Rossetto, and Elisa Baioff, as well as Lynne Golding and the Professional Development team at Fasken for arranging this wonderful work opportunity.
